DIRECTIONS TO MERJA FARMS NEAR SUN RIVER, MT: The field trial site is 11.3 miles from Interstate 15. Take Ulm Exit (#270) off I-15, 90 West past “First Peoples State Park” where pavement ends (3.5 miles), go straight 4.6 miles to a T, turn left then take the left fork uphill past “Buffalo Jump”. This is Goetz Road - continue west 11.3 miles on Goetz Rd to Trial Site, right turn on Private Rd, ¼ mile to campsite.

If predicted temperatures are very hot, the Field Trial Committee may elect to start on Saturday and/or Sunday at 6 a.m., break during the heat of the day, and resume braces in the late afternoon/evening. This change will be announced the evening before at dinner.
